AGREEMENT: A firm and binding agreement exists between Soltero Productions, hereinafter referred to as SP, and client only after this agreement has been signed and all fees have been paid. A retainer must be paid at the time of booking with the balance due and payable one week prior to the event. This retainer is made to secure your date for SP services. It is your guarantee that SP will not book someone else in your time slot. It is not a guarantee that SP will videotape your event. Only payment in full will guarantee this. The retainer is non-refundable. The agreement is for the exact date. If any payments have been made and the date of the event is changed, and SP is still available, you will not be penalized and SP will shoot on your new date. If SP is not available or if the event is canceled or the services of SP are canceled, SP will refund your money less the non-refundable retainer.

DISPLAY RIGHTS: It is understood that rights to exclusive use of the videotape and reproduction are reserved by SP and you are acting as agent for all members of the event and guests and grant SP all rights to use images, names, sounds, and/or recordings with any contest, exhibition, display, advertising, promotion, demonstration tape or other purposes. In return, SP agrees to use same in good faith and good taste.

RIGHTS: Client warrants that he/she has the legal rights to anything the studio will videotape including photos, music/sound recordings, videotapes or any other elements delivered to the studio for inclusion in the client's DVD. Client agrees to indemnify and hold the studio harmless for any loss, damage or liability for infringement of any rights arising from the use or sale of tapes client hires SP to produce, edit or duplicate.

STUDIO LIABILITY AND GUARANTEES: Liability is limited to refund of money paid. SP takes the utmost care in producing your videotape. In the unlikely event that a problem arises whether due to lateness, no show, accident, neglect, human error, loss of materials, Acts of God, or equipment or other failures and SP is unable to provide any videotape, all payments paid will be refunded. This is the extent of SP's liability. SP is not responsible for loss of video or audio quality due to restrictions at event locations. SP reserves the right to substitute videographers in the case of an emergency. In the case of an unforeseen obstacle SP does not guarantee any particular effect, interview or special request. SP is granted full editorial and production control by client regarding all aspects of the production and post-production editing. In the event a particular segment of the event is either not recorded, partially recorded, or not a part of the edited master tape, it is at the sole discretion of SP as the exclusive producer of the event video. Payment of any additional post-edited services requested by the client after event date will be due on or before the edited client copy of the recording is delivered.

OVERTIME CHARGES: When the event activities extend beyond agreed time for coverage, SP will notify the client. If agreement is made for continued coverage overtime will be billed at \$75.00 per half hour.

MEALS: Client agrees to provide meal service for SP staff at the time of guest meals, or, agrees to allow staff to leave the event for one hour.

PRODUCTION MATERIAL SUPPLIED BY CLIENT: Photographs, Invitation, Titles, Music, etc. and balance of payment are due one week prior to the event. All material will be delivered back to the client with finished DVDs. SP will not be responsible for the storage and safekeeping of any material associated with this project.

DELIVERY OF DVD: Will be approximately 10 to 12 weeks after event and all production material is provided and payment in full has been received. SP will notify client of any changes to this policy. Any changes must be requested within two weeks of delivery of the final copies. All changes must be approved by the editor.

If any portion of this agreement should be determined to be invalid, it is agreed that the invalidity of such portion shall not affect the validity of the remaining portions of this agreement. This agreement supersedes and replaces any previous document, correspondence, conversation, or other written and/or oral understanding.

CLIENT MUST NOTIFY SP, AT THE SIGNING OF THIS AGREEMENT, OF ANY SPECIAL REQUESTS REGARDING THE VIDEOTAPING OF THE EVENT. SOLTERO PRODUCTIONS WILL STRIVE TO MEET ALL REASONABLE REQUESTS.
